Delisting Determination, The Nasdaq Stock Market, LLC, October 15, 2024. BurgerFi International Inc.

The Nasdaq Stock Market LLC (the Exchange) has determined to remove from listing the securities of BurgerFi International Inc., effective at the opening of the trading session on October 25, 2024. Based on review of information provided by the Company, Nasdaq Staff determined that the Company no longer qualified for listing on the Exchange pursuant to Listing Rules 5101, 5110(b), and IM-5101-1.
